Levels of Hospice Care • Routine care-can occur anywhere • Respite care- for caregiver relief-maximum of 5 day period. • Continuous Care- for symptoms requiring extensive intervention. • General Inpatient (GIP) must occur in contracted LTC or hospital for symptoms that cannot be managed in the home setting.

Example 1: A beneficiary enrolled in Hospice goes to a physician's office for closed treatment of a metatarsal fracture, CPT code 28470. If the procedure is unrelated to the terminal prognosis, the physician should bill it with modifier GW (28470GW).

**Coding Guidelines: Part B Hospice Modifiers GV and GW**

Palliative care is patient and family-centered care that optimizes quality of life by anticipating, preventing, and treating suffering. Palliative care throughout the continuum of illness involves addressing physical, intellectual, emotional, social, and spiritual needs and to facilitate patient autonomy, access to information and choice.
