If you plead no contest to a criminal charge, you will have a conviction on your record, just as though you had pleaded guilty or been convicted after a trial. A potentially big advantage of a no-contest plea compared to a guilty plea has historically been that a no-contest plea could not be offered into evidence in a civil case.

### **Can a "No Contest" Plea Be Used Against Me in a Civil ...**

Although a no contest plea in a misdemeanor criminal case can't be used against you in a civil case, a no contest plea in a felony criminal case can be used as evidence against you in a civil case. Some people may associate pleading no contest instead of guilty in a criminal case to lighter sentencing, however, this is not always the case.
